



VIRGINIA DEPARTMENT OF TAXATION ORGANIZATION CHART

In August 1995, TAX undertook the first comprehensive reorganization of the agency structure to eliminate a layer of management and to more fully consolidate similar activities. This change provided valuable benefits to the organization, enabling the agency to maintain and in some cases improve operations despite a decline in staff. As part of its reengineering process under the unique Public/Private Partnership between Tax and American Management Systems, Inc., a new organizational structure was implemented beginning in July of 2001, which aligned the operational organization of the agency more closely with our customer needs. The following is a high level chart of the organization that went into effect in July.



PARTNERSHIP PROGRAM AND TAX ACCOMPLISHMENTS

TAX is currently in the third year of an engagement with American Management Systems, Inc. (AMS), an international consulting company based in Fairfax, Virginia, to completely reengineer the technology and business processes at TAX. The Partnership Project between TAX and AMS is the largest and most comprehensive of its kind ever conducted, in terms of both cost and scope. A 1993 report by the Joint Legislative Audit Review Commission (JLARC) to the General Assembly of Virginia recommended that the State Tax Accounting and Reporting Systems (STARS) computer system at the Department of Taxation be replaced. As funding was not available for this system replacement, the TAX Leadership Team began analyzing strategic alternatives to address the lack of traditional funding. The States of California and Kansas were pioneering a new "benefits" funding mechanism in partnership with the private sector, and representatives from the department subsequently visited these states to benchmark their projects. After fully investigating the alternatives for replacing the STARS system, the department requested that the legislature allow them to enter into a partnership arrangement with a private company.


Legislation was passed in 1996, and in July 1998 the Department of Taxation signed a five-year 'benefits funded' contract with AMS. Under the contract, AMS is helping to not only replace the core tax accounting system, but also completely reengineer the business processes at the Virginia Department of Taxation.

While contemplating the scope of the project, the Leadership Team considered a wide range of opportunities to enhance operational efficiency and to provide new and better customer services. The Partnership project between TAX and AMS is the largest in scope and size of any self-funded project in the nation, and encompasses not only new technology but also change management and organizational development.

The Virginia Department of Taxation (TAX) is an organization whose primary focus is on service to the customer. In deciding how to proceed with business reengineering, the agency settled on three key tenets that now make up the TAX Vision by which all our operations are evaluated:

- Customer first in everything we do;
- Manage change and organizational development to achieve a culture of high performance;
- Achieve performance that is a benchmark for government and for business.

To take the agency to the next level of performance, TAX leadership realized that not only were there technology issues that needed to be addressed, but fundamentally the focus of the agency had to change from operations to the customer. To evolve the agency into a high performing organization, TAX engaged in the largest public-private partnership ever conducted at a state revenue agency.



Funding for the Partnership

The Partnership project does not receive a single dollar of General Fund appropriation, rather it is funded through a process known as 'benefits funding.' The concept of benefits funding is simple. AMS provides state of the art hardware, and software and consulting services to improve collections performance and aid in compliance. These new revenues are then used to pay for the rest of the project without the need for any appropriations from the legislature. Once the project is fully paid for, these additional revenues will revert to Virginia's General Fund. Currently we estimate approximately \$35 million per year in additional compliance revenues will be available to the General Fund once the project is fully completed.

Benefits from Partnership initiatives have well outpaced our original estimates to this point in the project. Through November 2001, the project has generated more than \$69 million in benefits for use in paying the contract and covering additional operational costs for TAX. This is more than \$11 million ahead of our original projections for revenues generated at this point in the project. It is now estimated that because of the better than expected results TAX will save approximately \$8 million in interest charges over the life of the project.

Technology

Prior to the Partnership project, the most important tool used in providing service to customers was the integrated database system (STARS). This system is responsible for processing over 200,000 online transactions each day, running 200 nightly batch programs, and supporting 3,500 users, 2,600 of which are external to TAX. The STARS system was cutting-edge technology when it was developed in the 1980's, but it is nearing functional obsolescence. The single largest piece of the Partnership contract is the replacement of the STARS system with a new Integrated Revenue Management System (IRMS). In addition to IRMS, the Partnership has developed several first in the nation customer service initiatives that provide alternatives to traditional paper filing, as well as Customer Relationship Management capabilities.

Partnership Accomplishments

The Department of Taxation has undergone a world of change in the past four years, and has achieved many successes. Since July 1998 when the Partnership contract was signed, TAX has continued normal operations and indeed improved operations while at times more than 100 Tax staff – more than 13% of our total full time staff – have been devoted to project work.

The Partnership has implemented many new tools and technological solutions to our business problems. We have also provided a significant amount of training on the new tools through the Partnership and through management training to help our agency leaders work through the many issues involved with changing the agency.

Some of the key Partnership Successes include:

- > Implementing new automated data capture and imaging system
- > Developing new customer focused Individual Income Tax Form and Instructions
- Implementing Customer Relationship Management technology
- Developing a new Computer Aided Collections System
- > Implementing a new organizational structure to better meet agency goals
- > Developing the VATAXOnline suite of Internet applications that includes filing, payment and information services
- > Adding a Telefile system for filing simple tax returns over the telephone
- Replacing obsolete manual data entry equipment
- > Developing a coordinated compliance planning process
- > Implementing the first pilot program telecommuting effort at TAX for field personnel

But Partnership successes are not the only ones TAX has achieved in the past four years. Despite limited resources the operational areas at TAX have maintained their high standard for performance and in many cases continued to improve performance outside of the Partnership.

Customer Service


As always, service to our customers is paramount to our agency mission. While customer service extends to every facet of operations at TAX, several key areas where we interface directly with our customers continue to perform up to our high expectations.

- Customer Service representatives answered 535,000 calls in Fiscal Year 2001, up 10.6% from the previous year
- > TAX processed 611,000 electronically filed returns in Fiscal Year 2001, up approximately 24% over the same period last year
- TAX processed about 165,000 Telefile returns in Fiscal Year 2001, up from the 58,866 Telefile returns processed during the 2000 Telefile pilot program
- > TAX continued to successfully process more than 4 million business and miscellaneous returns per year
- > TAX processed approximately 4 million checks in Fiscal Year 2001, totaling more than \$5 billion in revenues
- During Fiscal Year 2001 Payments made by EFT grew from \$5.1 billion to more than \$5.5 billion, and the number of EFT participants grew by 45% to more than 165,000

Compliance Activities

The agency goal remains encouraging voluntary compliance while minimizing the intrusion and burden on taxpayers. To this end, several of the key Partnership initiatives described above provide tools and processes to effectively monitor compliance with tax laws with the least possible amount of disruption to the conduct of business in Virginia. With our goals in mind, TAX remains dedicated to ensuring that every taxpayer in the Commonwealth is in compliance with the existing tax laws.

- In Fiscal Year 2001compliance revenues totaled \$313.6 million in revenue, \$7.6 million above the forecast
- May 2001 was the highest compliance revenue month on record at TAX, with \$34.9 million collected.



Court Debt

In addition to these efforts, TAX is assigned the responsibility of providing collection services, on request, for delinquent court fines and fees. This program continues to grow, with 79% of all Virginia's Courts using TAX as a resource for collecting their debts. In Fiscal Year 2001 the Court Debt Collections Office increased collections by 8% over Fiscal Year 2000, and has posted to the Courts more than \$100 Million since it began in 1995.

Debt Set Off

The Debt Set-Off Collection Program matched more than 275,000 claims resulting in collections in excess of \$25 million in Fiscal Year 2001.

Key Legislative Initiatives

Car Tax

TAX helped successfully craft the legislation and administer the Personal Property Tax Relief Act.

Food Tax

Working with industry and local government officials, TAX developed regulations and administrative rules for implementing the sales tax reduction of food program.

Electricity and Natural Gas Deregulation

TAX staff helped develop and implement a completely new system of taxation for the deregulated electricity and natural gas industries.

Local Tangible Personal Property

In addition to assuming administrative appeals for local BPOL taxes, TAX has instituted a program to hear administrative appeals for local business tangible personal property tax appeals.

Compensation Reform

TAX human resources staff participated in the development of the Commonwealth's new compensation system, and it has been successfully implemented throughout the agency.

Small Purchase Credit Card

TAX implemented a small purchase credit card program that allows certain managers to make small purchases on a TAX credit card, providing both time and costs savings to the agency.

Electronic Transmittal of Fiscal Impact Statement

TAX was a leader in developing a process to electronically submit legislative documents to the General Assembly and make them available to the public online, greatly reducing the amount of paper associated with the legislative session and bringing a greater degree of transparency to the workings of the government.

TAX AWARDS

The Department of Taxation and the Partnership have been recognized as industry leaders and as a model of effective government administration by several national organizations during 2001.

Semifinalist - Innovations in Government Award – John F. Kennedy School of Government at Harvard University

This prestigious award endowed by the Ford Foundation is given to projects that provide innovative solutions to problems facing government and have the potential to be successfully replicated by others.

> NASCIO Outstanding Achievement Award

This award is given annually by the National Association of State Chief Information Officers to those programs and systems that have created cost effective, innovative solutions in the operation of state government.

> The Council of State Governments Eagle E-Government Award of Excellence

This award was given to recognize the Department of Taxation website and Internet services as one of the best executive Branch websites in all of state government across the nation.

> Federation of Tax Administrators Award for Management and Organization

This award is given to a program that demonstrates excellence in the effective use of resources in meeting the diverse mission of a state tax agency.


> E-Government Solutions Explorer Award

This award from the Association of Government Accountants was presented to the Tax Commissioner, Danny M. Payne for distinguished leadership in the public sector.







Table 1.3Number and Class of Returns by Virginia Adjusted Gross Income ClassTaxable Year 1999










Table 2.1 Corporate Income Tax Liability







The recordation tax is 15 cents on every \$100 value of property conveyed. Localities may impose a tax equal to one-third of the state tax.

The state tax on deeds is 50 cents per \$500. The tax on suits is \$5 for debts under \$50,000, \$15 for debts of \$50,001 to \$100,000, and \$25 for debts over \$100,000.

The tax on wills is 10 cents per \$100, or fraction of \$100, for estates exceeding \$5,000, including the first \$5,000. There is no tax on estates not exceeding \$5,000.

The tobacco tax is 1.25 mills per cigarette. Localities may impose additional levies. The peanut tax is 10 cents per 100 pounds.

The egg excise tax is 5 cents per 30 dozen cases for shell eggs, and 11 cents per 100 pounds of liquid eggs.

The soybean assessment rate is one-half of one percent of the net market value per bushel.

Some localities exempt certain of these categories from taxation.

Machinery and Tools includes machinery and equipment used in a manufacturing, mining, processing or reprocessing, radio and television broadcasting, dairy, or laundry business.

Merchants' Capital includes inventory of stock on hand, daily rental property, and all tangible personal property for sale.

Property of Public Service Corporations (PSC's) includes merchants' capital and real estate taxed at the real estate rate, and tangible personal property (motor vehicles, etc.) taxed at the tangible personal property rate.
